

LEGAL NOTICE

TO THE TAXPAYERS OF THE YAPHANK FIRE DISTRICT:

NOTICE IS HEREBY GIVEN, that a resolution was duly adopted by the Board of Fire Commissioners of the YAPHANK FIRE DISTRICT, Town of Brookhaven, County of Suffolk, State of New York, on the 5th day of November 2024, subject to permissive referendum as provided for by the Town Law.

An extract of the resolution is as follows:

THE YAPHANK FIRE DISTRICT SHALL SELL THE FOLLOWING VEHICLE: ONE (1) 2007 PIERCE PUMPER NO LONGER NECESSARY FOR THE DISTRICT'S USES AND PURPOSES VALUED IN EXCESS OF FIFTY THOUSAND (\$50,000.00) DOLLARS IN ACCORDANCE WITH THE AUTHORITY VESTED IN THE BOARD OF FIRE COMMISSIONERS UNDER SECTION 176 SUBDIVISION 23 OF THE TOWN LAW WITH THE ACTUAL PRICE OF SALE TO BE BASED UPON MARKET FORCES.

Sale of said vehicle is subject to mandatory referendum as required under Section 176 subdivision 23 of the Town Law and in accordance with procedures for permissive referendums as described in the General Municipal Law.

RESOLUTION

SALE OF 2007 PIERCE PUMPER

WHEREAS, the Board of Fire Commissioners of the YAPHANK FIRE DISTRICT is vested with the authority to sell equipment owned by the District which it determines is no longer necessary for the uses and purposes of the District pursuant to Section 176 subdivision 23 of the Town Law; and

WHEREAS, the Board has determined that the following vehicle: ONE (1) 2007 PIERCE PUMPER VEHICLE IDENTIFICATION # 4PICC01A47A007203 owned by the district is no longer necessary for its uses and purposes; and

WHEREAS, the Board has determined to sell such vehicle valued in excess of Fifty Thousand (\$50,000.00) Dollars in accordance with the authority vested in the Board of Fire Commissioners under Section 176 subdivision 23 of the Town Law.

IT IS RESOLVED that pursuant to the authority vested in the Board of Fire Commissioners under Section 176 subdivision 23 of the Town Law, the YAPHANK FIRE DISTRICT shall sell such vehicle whose actual value shall be determined by **market forces**.

BE IT FURTHER RESOLVED that this resolution is subject to a mandatory referendum as required under Section 176 subdivision 23 of the Town Law and in accordance with procedures for mandatory referendums as described in the General Municipal Law.
