

INSTALLATION DINNER POLICY

The Installation Dinner Policy of the Yaphank Fire District, effective this date, shall be as follows:

Invitees: At Fire District expense, invited attendees shall include:

- i). Any additional guests that the Board determines their presence is required in order to properly recognize chief officers to be installed and other firefighters to be honored or to thank them for their service to the Department or District.

- j). In the event that a 5+ year member of the Department expires, their significant other and one guest (or whoever the Board determines) will be invited to the following years Installation Dinner.

In the case where a member is the spouse or significant other or cohabitating with a member of the Fire Department, Ladies Auxiliary, or an employee, or both are members in the Fire Department then no additional guests are allowed.

Medical Leave/VFBL invites:

1. Any member/employee who is on medical leave (not from a line of duty injury) by the time invitations are prepared for printing will not be invited to the dinner and is unable to attend as a guest. However, if you are cleared for duty prior to the RSVP date, you will then be eligible to attend with proper documentation from the District Medical Authority.
2. Any member/employee who is on medical leave from a line of duty injury will be invited to the dinner contingent on their doctor's medical documentation being submitted to the Chief and District every three (3) months during their medical leave.
3. Any member who is not a life member and is not in good standing will not be invited and is unable to attend as a guest.
4. Any member who is suspended or is out on medical 51% of the year will not be invited.

All Department members must participate in uniform inspection prior to the beginning of the ceremony. Refusal will result in member being asked to leave dinner.

Any Officer being sworn in MUST remain in their uniform until the completion of the Oath of Office.

Roll call to be taken and attendance sheet submitted for department membership.

An attempt will be made to verify a "head count" for the purpose of verifying the final charge made by the catering facility.

Food: Paid for by the district.

Flowers: Flowers presented to the three present Chief's significant others, the five present Commissioners significant others, the past President of Ladies Auxiliary, and the District Secretary. There will not be multiple bouquets given to any individual.

Cost of Gifts/Favors: If provided, only a nominal expense per person.

Cost of Music/Entertainment: Paid for by District with 5-hour cap, no overtime allowed.
